**Degree/Major:** BSBA with focus areas in Accounting, Finance, Management, and Marketing  
**Program Admission Requirements:** ENG 111, MTH 163, ACC 211, ECO 202, and BUS 100  
**Foreign Language Requirements:** Met with completion of transfer AS degree  
**Additional Courses and/or Substitutions:** CST 100 or CST 110, ITE 119, PHI 220  
**Comments:** All students must have a cumulative GPA of 2.5 or more and have completed at least 24 credits.

**Degree/Major:** BSBA with focus area in Information Systems  
**Program Admission Requirements:** As above  
**Foreign Language Requirements:** As above  
**Additional Courses and/or Substitutions:** ITE 120 or ITE 100 and CSC 201  
**Comments:** As above

**UVA Continuing and Professional Studies**

---

**Degree/Major:** BIS with concentration in Business  
**Program Admission Requirements:** 60 transferable credits from regionally accredited institutions to include the following: 6 credits in English Composition, 6 credits in Humanities, 6 credits in Social Sciences, 12 credits in Math and/or Natural Sciences, and the balance of credits in transferable electives  
**Foreign Language Requirements:** None  
**Additional Courses and/or Substitutions:** MTH 163 does not transfer. Transferable computer courses must be taken within 5 years of admission. Four pre-requisite courses are ACC 211; ECO 201; ECO 202; and MTH 157, 240, or 241 as part of, not in addition to, the 60 transferable credits.  
**Comments:** All students must have a cumulative GPA of 2.0 or more. Pre-admission evaluation of credits and meeting with a recruitment counselor are required.

**UR School of Professional and Continuing Studies (SPCS)**

---

**Degree/Major:** BS in Professional Studies – majors in Information Technology Management, Information Security, Human Resource Management, and Paralegal Studies  
**Program Admission Requirements:** ENG 111, MTH 163 or higher recommended  
**Foreign Language Requirements:** None; 3 credits of a foreign language will fulfill an area of study.  
**Additional Courses and/or Substitutions:** PHI 220 recommended  
**Comments:** Minimum cumulative GPA of 2.0; will transfer up to 60 hours for courses completed with grades of C and above; English placement test and admissions meeting with academic advisor required.

**Degree/Major:** BBA in Accounting, Economics, Finance, Management, and Marketing

**Program Admission Requirements:** There are 10 core College of Business (COB) pre-requisites; 6 are available at Reynolds - ACC 211, ACC 212, ECO 201, ECO 202, MTH 270, and MTH 240. The remaining four courses will be taken at JMU during the transfer student's first semester.

**Foreign Language Requirements:** None

**Additional Courses and/or Substitutions:** MTH 240 should be taken as an approved elective.

**Comments:** Students who achieve a 2.7 GPA in the 10 BBA core courses, with the exception of calculus, will be assured admission to the College of Business and COB 300-level (junior-level) courses. Only grades for courses taken at JMU will be used in the GPA. With the completion of MTH 240, Reynolds students will have 4 remaining COB core courses totaling 12 credits to complete during their first semester at JMU: COB 202, COB 204, COB 218, and COB 291.

**Degree/Major:** BBA in Computer Information Systems

**Program Admission Requirements:** There are 10 core College of Business (COB) pre-requisites; 6 are available at Reynolds - ACC 211, ACC 212, ECO 201, ECO 202, MTH 270, and MTH 240.

**Foreign Language Requirements:** None

**Additional Courses and/or Substitutions:** MTH 240 should be taken as an approved elective, and students can take either ITP 112, ITP 120, or ITP 136 to fulfill the requirement for CIS 221 at JMU. CIS 221 is not a prerequisite for admission to COB.

**Comments:** Students who achieve a 2.7 GPA in the 10 BBA core courses, with the exception of calculus, will be assured admission to the College of Business and COB 300-level (junior-level courses). Only grades for courses taken at JMU will be used in the GPA. With the completion of MTH 240, Reynolds students will have 4 remaining COB core courses, totaling 12 credits to complete during their first semester at JMU: COB 202, COB 204, COB 218, and COB 291.

**Degree/Major:** BBA in International Business

**Program Admission Requirements:** There are 10 core College of Business (COB) pre-requisites; 6 are available at Reynolds - ACC 211, ACC 212, ECO 201, ECO 202, MTH 270, and MTH 240.

**Foreign Language Requirements:** Foreign language proficiency through the intermediate level "202" should be completed prior to transfer.

**Additional Courses and/or Substitutions:** MTH 240 should be taken as an approved elective.

**Comments:** Students who achieve a 2.7 GPA in the 10 BBA core courses, with the exception of calculus, will be assured admission to the College of Business and COB300 (junior-level courses). Only grades for courses taken at JMU will be used in the GPA. With the completion of MTH 240, Reynolds students will have 4 remaining COB core courses, totaling 12 credits, to complete during their first semester at JMU: COB 202, COB 204, COB 218, and COB 291.

**Degree/Major:** BS in Quantitative Finance (QFIN)

**Program Admission Requirements:** QFIN is an interdisciplinary major that includes possible minors in Economics and Math. QFIN does not require students to complete the BBA core courses. The following courses are required: ACC 211, MTH 173, MTH 174, MTH 277, ECO 201, and ECO 202.

**Foreign Language Requirements:** None

**Additional Courses and/or Substitutions:** MTH 240 and MTH 277 should be taken as approved electives.

**Comments:** Students may want to consider completing the Science AS – Mathematics Specialization and taking ACC 211 as 1 extra course to fulfill the QFIN business degree's math requirements.

## VSU

---

**Degree/Major:** BS in Accounting, Management, Management with HR concentration, Management Information Systems, and Marketing

**Program Admission Requirements:** ENG 111, MTH 163, and BUS 100 are recommended

**Foreign Language Requirements:** None

**Additional Courses and/or Substitutions:** Nine Core Business prerequisites are available at Reynolds: ACC 211, 212, BUS 100, BUS 220 (or MTH 240), BUS 240, ECO 201, 202, FIN 107, and ITE 115. Other transferable courses include: ENG 111, 112, ENG Lit, MTH 163, 270, HIS Elective, and Global Studies Elective (i.e., World HIS or Foreign Language).

**Comments:** Students must achieve a C or higher in all courses for transfer. Students are expected to have a 2.5 GPA or higher for full admittance into the Business phase (3rd year standing) of our program. Accounting majors must earn a grade of a B or higher in ACC 211 and 212. A C grade is sufficient for non-Accounting majors. Students should also refer to the Articulation Agreement between Reynolds and the Reginald F. Lewis College of Business at VSU.

## UMW

---

**Degree/Major:** BS Business Administration with emphasis available in Business Administration, Accounting, Management, Management Information Systems, and Marketing

**Program Admission Requirements:** To be admitted into the College of Business (COB) student must complete 5 pre-business courses. To complete the courses at Reynolds students need to take ACC 211, ACC 212, ECO 201, ECO 202, MTH 157 (or 240 or 241).

**Foreign Language Requirement:** All undergraduate students at UMW pursuing a BA/BS degree will be required to complete through the intermediate level of a foreign language (202). This requirement can also be completed at Reynolds.

**Comments:** To be competitive for admission to UMW students should have a cumulative GPA of 3.0 or higher. To qualify for guaranteed admission students need a cumulative GPA of 3.25 or higher.

**Degree/Major:** BLS in Leadership and Management

**Program Admission Requirements:** To be eligible for the BLS program students must have a minimum GPA of 2.5, however, a competitive applicant will have a 3.0. Additionally, students need a minimum of 30 transferrable credits to qualify. The Bachelors of Liberal Studies

program is for non-traditional transfer students and students must meet certain criteria (listed under comments)

**Foreign Language Requirement:** None

**Comments:** To qualify as a non-traditional transfer for the Leadership and Management program students must meet one of the following criteria: 6 or more years of high school, married, dependent children, or military. The Leadership and Management major is done in an accelerated 8-week format for major courses and offered in the evenings.

## **Longwood University**

---

**Degree/Major:** BSBA with concentrations in Accounting, Economics, Finance, Information Systems and Security, Management, Marketing and Real Estate

**Program Admission Requirements:** ENG 111, college-level math, 4-credit lab science, ACC 211, ACC 212, ECO 201 and ECO 202

**Foreign Language Requirements:** Waived with completion of Associate of Arts and/or Science

**Additional Courses and/or Substitutions:** Prefer students complete statistics for college-level math

**Comments:** All students are required to have a cumulative GPA of 2.5 or better, as well as completed 24 credit hours.
